

PRIVACY POLICY

Alotsold Vehicle Auctions Limited (We/Us/Our) is committed to protecting and respecting your privacy.

This Privacy Policy (together with Our Terms of Use Policy and any other documents referred to on it) sets out the basis on which any personal data We collect from you, or that you provide to Us, will be processed by Us. Please read the following carefully to understand Our views and practices regarding your personal data and how We will treat it. The definitions set out in Our website terms and conditions www.alotsoldvehicleauction.com/pdfs/websitetermsandconditions.pdf apply to this policy.

For the purpose of the Data Protection Act 1998 (the Act), the data controller is Alotsold Vehicle Auctions Limited of 20-22 Wenlock Road, London, N1 7GU.

1. INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- 1.1 information that you provide by filling in forms on the site www.alotsoldvehicleauction.com (the Website). This includes information provided at the time of registering to use the Website, subscribing to Our service, posting material or requesting further services. We may also ask you for information when you enter an auction or any promotion sponsored by Alotsold Vehicle Auctions Limited, or when you report a problem with the Website;
- 1.2 if you contact Us, records of that correspondence;
- 1.3 completed surveys that you respond to which We use for research purposes, although you do not have to respond to them;
- 1.4 details of transactions you carry out through the Website and of the fulfilment of your orders; and
- 1.5 details of your visits to the Website including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for Our own billing purposes or otherwise and the resources that you access.

2. IP ADDRESSES AND COOKIES

- 2.1 We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to Our advertisers. This is statistical data about Our users' browsing actions and patterns, and does not identify any individual.
- 2.2 For the same reason, We may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help Us to improve the Website and to deliver a better and more personalised service. They enable Us:

2.2.1 to estimate our audience size and usage pattern;

2.2.2 to store information about your preferences, and so allow Us to customise the Website according to your individual interests;

2.2.3 to speed up your searches; and

2.2.4 to recognise you when you return to the Website.

2.3 You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting you may be unable to access certain parts of the Website. Unless you have adjusted your browser setting so that it will refuse cookies, Our system will issue cookies when you log on to the Website.

2.4 Please note that Our advertisers may also use cookies, over which we have no control.

3. WHERE WE STORE YOUR PERSONAL DATA

3.1 The data that We collect from you may be transferred to, and stored at, a destination outside the European Economic Area ("EEA"). It may also be processed by staff operating outside the EEA who work for Us or for one of Our suppliers. Such staff maybe engaged in, among other things, the fulfilment of your order, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

3.2 All information you provide to Us is stored on our secure servers. Any payment transactions will be encrypted using the relevant technology. Where We have given you (or where you have chosen) a password which enables you to access certain parts of the Website, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

3.3 Unfortunately, the transmission of information via the internet is not completely secure. Although We will do our best to protect your personal data, We cannot guarantee the security of your data transmitted to the Website; any transmission is at your own risk. Once We have received your information, We will use strict procedures and security features to try to prevent unauthorised access.

4. USES MADE OF THE INFORMATION

4.1 We use information held about you in the following ways:

4.1.1 to ensure that content from the Website is presented in the most effective manner for you and for your computer;

4.1.2 to provide you with information, products or services that you request from Us or which We feel may interest you, where you have consented to be contacted for such purposes;

4.1.3 to allow you to participate in interactive features of Our service, when you choose to do so; and

4.1.4 to notify you about changes to Our service.

4.2 We may also use your data, or permit selected third parties to use your data, to provide you with information about goods and services which may be of interest to you and We or they may contact you about these by e-mail, post or telephone.

- 4.3 If you are an existing customer, We will only contact you by electronic means (email or SMS) with information about goods and services similar to those which were the subject of a previous purchase by you.
- 4.4 If you are a new customer, and where We permit selected third parties to use your data, We (or they) will contact you by electronic means only if you have consented to this.
- 4.5 If you would like your details to be used in this way, please contact Us by email at info@alotsoldvehicleauction.com.
- 4.6 We do not disclose information about identifiable individuals to Our advertisers, but We may provide them with aggregate information about Our users (for example, we may inform them that 300 women aged under 25 have clicked on their advertisement on any given day). We may also use such aggregate information to help advertisers reach the kind of audience they want to target (for example, companies in N1). We may make use of the personal data We have collected from you to enable Us to comply with Our advertisers' wishes by displaying their advertisement to that target audience.

5. DISCLOSURE OF YOUR INFORMATION

5.1 We may disclose your personal information to any member of Our group, which means Our subsidiaries, Our ultimate holding company and its subsidiaries, as defined in section 1159 of the UK Companies Act 2006.

5.2 We may disclose your personal information to third parties:

5.2.1 in the event that We sell or buy any business or assets, in which case We may disclose your personal data to the prospective seller or buyer of such business or assets;

5.2.2 if Alotsold Vehicle Auctions Limited or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets; or

5.2.3 if We are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply Our Terms of Website Use Policy or Conditions and other agreements; or to protect the rights, property, or safety of Alotsold Vehicle Auctions Limited, Our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

6. YOUR RIGHTS

6.1 You have the right to ask Us not to process your personal data for marketing purposes. We will usually inform you (before collecting your data) if We intend to use your data for such purposes or if We intend to disclose your information to any third party for such purposes. 6.2 The Website may, from time to time, contain links to and from the websites of Our partner networks, advertisers and affiliates. If you follow a link to any of these websites, please note that these websites have their own privacy policies and that We do not accept any responsibility or liability for these policies. 7. ACCESS TO INFORMATION

The Act gives you the right to access information held about you. Your right of access can be exercised in accordance with the Act. Any access request may be subject to a fee of £10 to meet Our costs in providing you with details of the information We hold about you.
